## Informal meeting of the Ascension Island Council 1630 on Thursday 25th July 2019 at the Court House

## **MEETING SUMMARY**

2. <u>Matters arising</u> (from last informal meeting on 11 Jul 2019) covered: **Firearms Ordinance** (<u>Update</u>: this item would be held over until the arrival of the new Crown Counsel); **Street lighting** (<u>Update</u>: The poles were delivered on the last FIRS but the heads and batteries would arrive on the 29 July FIRS. Once off-loaded and assembled the trial would start); **Electoral Register** (<u>Update</u>: Employing organisations have been contacted to update their lists. The Administrator would arrange for the Council dissolution/Date of election notice to be issued soon); **Georgetown Swimming pool** (<u>Update</u>: Owing to unfavourable sea conditions the work was now planned for 2 Aug. The ladders were due to arrive on the 20 Sep FIRS); **Turtle Ponds** (<u>Update</u>: The wall repairs had been completed and there was some minor landscaping still to do. A public notice would be issued in August when the smaller pond would be officially reopened. Work on the larger pond would continue in slower time); **Shopping Basket** (<u>Update</u>: After some discussion about the merits of a 'shopping basket' system and about which items/expenditure ought to be included, all agreed that starting some kind of annual record would provide a useful comparison tool for decision making in future).

**3.** <u>Island Policing</u>: the discussion covered concerns about noise and public order. Insp Kewley outlined his aspirations to encourage the clubs to take a firmer position with regard to patrons' behaviour and music volume in return for greater flexibility at certain times. He also confirmed that Police investigations were victim-led and so would normally require a formal complaint to be made. In response to questions about drones Insp Kewley offered to prepare a notice to explain their capabilities, likely uses and restrictions. It was agreed that Insp Kewley's participation would become a regular feature of informal meetings at approx 3 monthly intervals.

**4.** <u>Payment of AIG food allowance</u>: the Administrator introduced a Memorandum to explain AIG's decision to pay the food allowance to staff while off island. All agreed that this was a positive decision.

**5.** <u>Any other business</u> covered: (a) Resignation of Dir Ops & Facilities; (b) MPA designation with conditionality; (c) Pier head access during ship-to-shore operations; (d) School bus roadworthiness; (e) Council sub-committees membership.

  - Informal 22 Aug 2019 at 1630
  - No further meetings for current AI Council (dissolved on 1 Sep)
